Tournament Format: The (4) Divisions are Single Elimination with consolation round for first round losers. Matches will be best 2 of 3 games to 11 points. Use of 2-3 tables for events.

Divisions: Four Divisions: **Open** Championship Singles, **Adult Recreational** Singles, **Juniors Singles** (17 years & under) and **Youth Singles** (12 years & under). Separate Male & Female events per division with 3 or more entrants.

Locations: Aug. 27: **Minnesota Park** (W. 35th & Minnesota Dr.) or
Sept. 15: **Delany Park Strip** (10th & D Street)

Instructions & Rules: **Player Check in required at least 20 minutes PRIOR to your division start time at control desk.** Games to 11 points, must win by 2 pts. Matches will be best 2 of 3 games. If time limits become an issue then matches will be ONE game to 15 POINTS. Good sportsmanship is expected. Decision of tournament director is final.

Entry Fees: Youth & Junior Singles \$5., Adult Recreational \$10 & Open Singles \$20., * Late Fees, (day of event) : \$5., Late Entries add \$5 after 11PM on 8/26/14 or 10PM on 9/14/14 for each event.

Entry Deadline: **Tuesday 8/26/14 @ 11PM. PRIOR to 8/27/14 tournament. Sunday 9/14/14 @ 10PM. PRIOR to 9/15/14 tournament.**

Full entry form & FEES must be received by deadline to avoid late fees. Entries received after maximum entries or day of event accepted based on available space. A **waiting list** for over limit entries & openings if entrants are NO SHOW. **No refunds after deadline or no show.**
