Restrictions: Participants limited to maximum of 2 singles events and not at same starting time. And limited to ONE division in doubles. Known top-rated players will be limited to Open and appropriate skill divisions. Doubles for B/C limited to B-D level players only. New participants will be estimated by tournament committee. Esquire Singles is limited to ages 40 & over PLUS under 1400 skill level.

Format: All singles divisions will have preliminary round robin pools. Events with 5 or less entries then one RR pool with final results. But if 6 or more entries will be split in to 2 or more round robin pools. Then top 1 or 2 will advance to single elimination playoffs & finals.

Rules: Check in: 15 minutes PRIOR to your first match at control desk. Games to 11 points, must win by 2 points. Matches will be best 3 of 5 games. Except for Finals of Open Singles is best 4 of 7. Good sportsmanship is expected. All USATT & ITTF rules apply. Decision of tournament director is final.

Entry Deadline: Fri. 3/15/13 by 6PM. Full entry form & FEES must be received by deadline to avoid late fees. (No Exceptions.)
