Events: 12 Events/Divisions: 4 Skill Singles, 2 Doubles, 1 Women's, 1 Seniors, 4 Juveniles or Juniors Male or Female **Restrictions:** Participants limited to maximum of 2 singles events and not at same starting time. And limited to ONE division in doubles. Known top-rated players will be limited to Open and/or B divisions. Doubles for B/C limited to B-D level players only. New participants will be estimated by tournament committee.

Format: All singles divisions will have preliminary round robin pools. Events with 5 or less entries then one RR pool with final results. But if 6 or more entries will be split in to 2 or more round robin pools. Top 1 or 2 will advance to single elimination playoffs & finals. **Rules:** Check in: 15 minutes PRIOR to your first match at control desk. Games to 11 points, must win by 2 pts. Matches will be best 3 of

5 games. Good sportsmanship is expected. All *USATT & ITTF* rules apply. Decision of tournament director is final.
