**LOCATION:** Arctic Rec Center, 4855 Arctic Blvd. Anch, AK 99503

**Eligibility & Restrictions:** All Ages, genders & skills levels welcome. All singles matches. Minimum entries is 12, Maximum 24 players. All players "ranked or seeded" based on known skill, USATT rating or experience. Self skill level suggested below for new participants.

**Format: Double Round Robin (RR)** This format is designed to allow entrants to play in **5 to 9 total** matches in 2 rounds. **PRELIMINARY RR.** Top Skill level known ranked players will be distributed across preliminary pools mixed with various skill level players in a snake ranked system. Preliminary round robin will have 3 to 6 pools of 4 players per pool. Results from preliminary round places you in 2nd round of A, B, C & D Division **PLAYOFF RR** pools based on your 1st, 2nd, 3rd and/or 4th place preliminary finished position. Final Playoffs could have 3 divisions, A, B & C/D depending on number of entrants. It is possible RR Pools could consist of 3, 4, 5 or 6 players.

**Rules: Check in by 11:10AM at control desk.** Matches will be best 3 of 5 games. Games to 11 points, *USATT & ITTF* rules apply. Good sportsmanship is expected. Decision of tournament director is final. Matches are self umpired w/ assistance from referee as needed.

**Entry Deadline: Monday 2/24/20 by 10PM.** Full entry form & FEES must be received by deadline to avoid late fees. Entries received after this date/time will only be accepted based on available space. **No refunds after 2/24/20 deadline.** Once 16 entrants have been received the WAIT LIST to make 20 or 24 PLAYERS allowing 4 player added groups. Goal is 24 player in 6 prelim pools of 4 players per pool. Enter NOW... Space is LIMITED, DO it Today!
