One Big Event: Double Round Robin format. Play 5-8 SINGLES matches. **Restrictions:** All skills levels welcome. Entry is limited to 20 participants.

Minimum 16 players, increased to 20 players.

**Format:** Doors open, set up & practice 11:30 AM. Giant Round Robin is 2 tiers of matches from first PRELIMINARY to the second PLAYOFF round.

Your result from the preliminary round will place you in A, B, C & D pools based

on 1st, 2nd, 3rd and/or 4th place from each pool. Preliminary round robin will have 4 or 5 pools. Each RR pool will have 3-4 players. Top seeded players will be distributed between each preliminary pool with various skill level players. Format will allow entries 6 to 7 matches over the giant RR format event. You could play 18 to 35 games!! Better be prepared!

Rules: Check in by 12:15PM at control desk. Matches will be best 3 of 5 games. Games to 11 points, All USATT & ITTF rules apply. Good sportsmanship is expected. Decision of tournament director is final. Matches are self umpired w/ assistance from referee as needed. Entry Deadline EXTENDED: Wed 4/12/17 by 10PM. Full entry form & FEES must be received by deadline to avoid late fees. Entries received after this date/time will only be accepted based on available space No refunds after 4/12/17 deadline. 16 entrants have been received and PREPAID WAIT LIST is start to make 20 PLAYERS total.
